#### Introduction

The purpose of the Statement of Community Involvement is to set out the principles for engaging and consulting with local communities – including residents, organisations and businesses and any interested parties on planning matters.

Consultation and engagement on planning matters set out in this Statement seek to go beyond the minimum regulatory requirement for community involvement in the planning of the scheme.

# **Notification & Engagement Techniques Used**

BEJSC acknowledge and welcome the right for anyone to comment on the preparation of a planning submission document; however, it is important to ensure inclusivity throughout the plan-making process. A range of notification and engagement techniques have been employed to raise awareness and to encourage participation at each stage of plan preparation. BEJSC recognised that some potential participants in the consultation would favour paper methods of communication, therefore electronic media has not been solely relied upon.

The following techniques have therefore been utilised: -

- BEJSC operates a database of individuals and organisations that have expressed an interest in project Thunderbirds or are statutory consultees. Those who wish to be involved or updated will be directly notified at each stage either through email, letter or via the website.
- Production of a dedicated project website, located at <a href="www.bejsc-swimmingpool.co.uk">www.bejsc-swimmingpool.co.uk</a> to provide an online resource for the following:
  - History of the club
  - Background to the project
  - o Plans & Drawings of the proposal
  - Considerations to the planning process
  - o Timetable of club and community use
  - Feedback forms
  - Online Questionnaire to establish support or concerns
- Production of a dedicated Facebook page for the project to ensure a wide audience is available and to keep consultees upto date on progress
- Paper copies of consultation material, including comment forms, have been made available by emailing <u>office@bejsc.co.uk</u> to request them to be posted to community addresses, with a reply-paid envelope provided.
- Notices have been placed in a local magazines and business shopfronts advertising consultation and engagement opportunities, where appropriate.
- Media briefings/press releases/articles have also been issued via local media.

Leaflets (450 Number) were designed, written, printed and delivered to residents within 0.5km of the proposed site to inform and engage with residents and businesses/schools most likely to be affected or to benefit from the project.

Other events may include drop-in sessions, public exhibitions and/or targeted workshops. Presentations and regular engagement with Wooburn & Bourne End Parish Council meetings will continue to be utilised where possible. The type of

event undertaken will be dependent on a number of factors, including the consultation stage, and time and resource constraints. Careful consideration will be given to the timing, venue and format of events to continue to ensure accessibility and inclusivity.

## **Submitting Comments**

BEJSC are continuing to operate an online public consultation system where comments may be made.

In addition BEJSC have been running an ongoing online questionnaire, the results of which are included in the following pages. Electronic media, although the most quick and efficient method for submitting comments, is not the only acceptable method. Comments may be submitted during each stage of formal public consultation in the following ways:

Comment forms are normally provided in paper or Word document format on request.

Comments must be made during the prescribed consultation period.

Any comments that are offensive, threatening, obscene, racist or illegal in any other way are not accepted.
